Bids shall be opened in the presence of bidder's representatives who choose to attend **13:00 hour on 2079-09-24 (08 January 2023)** at the office of Gorkhapatra, Corporation, Dharmapath, Kathmandu Nepal Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security as mentioned above which shall be valid for minimum 30 days beyond the bid validity period.
